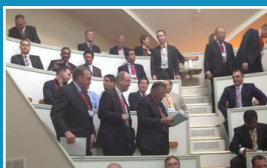
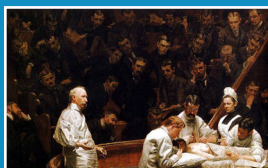
Group Rate: \$209/night plus taxes-single or double occupancy.

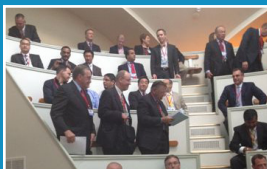
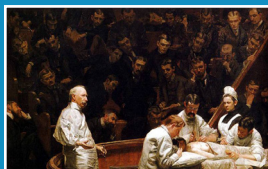
